- Bank of Sharjah acts as lead arranger, bookrunner in \$155mln loan for 'Dαewoo Engineering'. Arranged in collaboration with other regional banks.
- Abu Dhabi National Hotels posts 216% higher profits in 2024. Revenue from contracts with customers witnessed a 77% YoY hike to AED 2.88 billion at the end of December 2024.
- E&'s profits leap in 2024 on demand for digital services. Telecom group recorded a 10.10% growth in revenue increased to AED 59.20 billion, compared to AED 54.75 billion in 2023.
- Air Arabia posted a record pre-tax net profit of AED 1.60 billion in 2024, an annual rise of 4% from AED 1.54 billion, according to the financial results.
